Alexco Resource Corp. (the Company) is a Canadian corporation with corporate headquarters in Vancouver, British Columbia, Canada. Alexco operates two distinctive yet complimentary businesses; mine exploration, development and operations and environmental consulting and remediation services.

### SAFETY COORDINATOR

Reporting to the General Manager, the successful candidate will be responsible for:

- Developing safety training strategies & courses for the construction and operational phases of the project.
- Collecting, analyzing and reporting data relating to the implementation of preventative strategies, critical incidents and injury frequency rates.
- Developing and promoting strategies for enforcing safety standards and regulations across the district.
- Safeguard the construction and operating sites through safety measures that protect company assets & people.
- Managing emergency preparedness programs that ensure the site is able to react systematically and effectively in a crisis and minimize damage or risk.
- Included in Mine preparedness is the ability to train and participate as an active member of Mine, Surface Rescue and firefighting.
- Ability to write, communicate, implement and follow through with safety procedure and policies.
- Liaison with YTWCB and territorial agencies.

The candidate will have a university degree in a safety related discipline and or certified safety professional. A professional designation or certification in a safety related area, an Advanced First Aid certificate and a Mine Rescue certificate are required. Three to five years of safety and training management experience in an underground mining environment is required as well as a minimum of one to two years experience in a supervisory role.

Alexco maintains camp facilities in Elsa, Yukon, where employees and contractors are housed. This position is based in Elsa and the rotation schedule is 14 days on and 14 days off. Alexco provides full benefits packages comparable to current industry standards.
