Education & Experience Requirements:

- Valid EMR or OFA Level 3 – 2 years experience minimum;
- Experience in the Mining Industry;
- Valid driver's license;

- Ability to take direction and then act independently;

Criteria & Conditions:

- Work is performed in the Mine or Mill which may include exposure to extremes in temperature and humidity, moving mechanical parts, risk of electrical shock, toxic chemicals, explosives, fumes or airborne particles;
- While performing the duties of this job, the employee is required to stand, sit, demonstrate manual dexterity, climb stairs and ladders, and work on elevated platforms;
- Occasionally may be required to lift moderately heavy to heavy objects (up to 50 pounds) during the course of the workday;
- Personal protective equipment is required on a regular basis, including hard hat, hearing protection, safety glasses, safety foot wear, and as needed, respirator, rubber steel-toe boots, protective clothing, gloves and other protective equipment as required; and
